Coastal Bend Showcase - Rules & Regulations

1. **Installation & Dismantling of Exhibits:** Installation of booth(s) must be complete 1 hour prior to Event opening; Vendor agrees not to dismantle booth(s) prior to **3:15 p.m.** on the day of Event. Booths must be occupied at all times during show hours. (Refer to show hours on the front of your contract.)
2. **Security:** Security is not provided. Vendors need to provide their own booth security before, during and after Event. Lessor does NOT assume liability for loss or damage by any cause. Vendor is solely responsible for the safe keeping of its property at all times.
3. **LIABILITY AND INDEMNITY:** Neither the "Coastal Bend Showcase", Aransas Pass Civic Center, Keep Aransas Pass Beautiful, management, employees nor those acting for them, shall be liable for any injury to person or property from any cause. Vendor on whose leased space or through whose fault or neglect said injury shall have occurred shall indemnify and hold the Lessor HARMLESS AGAINST ANY CLAIM ARISING OUT OF SUCH INJURY.
4. **Insurance:** It is recommended by Lessor that Vendor protect him/herself fully with regard to any property loss through fire, theft or physical damage as a result of Event. Lessor assumes no responsibility whatsoever in connection with such losses or in connection with injury to the employees of Exhibitor. Contact your Insurance Company for a binder to cover your Exhibit. Your insurance binder should cover your products and liability in the event anyone is injured as a result of your Exhibit.
5. **Sound Devices & Media Videos:** The use of sound devices and video players is allowed as long as it doesn't disturb adjacent Vendors. Lessor reserves the right to restrict exhibitors from using sound devices or any other undignified methods of attracting attention that interfere with the best interests of exhibitors as a whole.
6. **Show Activities:** Vendors must confine their operation to their allotted space. Circulars or advertising material may be distributed only from the Vendor's booth and perimeters.
7. **Subcontracting & Booth Sharing:** This agreement shall not be assigned and no rights granted to the Vendor in this agreement, shall be subcontracted and or transferred to another party. Booth sharing is not permitted.
8. **Floor Plan:** The Coastal Bend Showcase reserves the right to adjust the Final Floor Plan, if necessary; however, Lessor will make every attempt to accommodate all Vendors' booth requests.
9. **Fund Raising & Raffles:** Fund raising activities and/or raffles are strictly prohibited unless prior written consent is obtained from the Coastal Bend Showcase. All approved drawings for prizes and/or giveaways must be completed by 3:00 p.m. on the day of Event.
10. **Food & Beverage:** It is possible that food or beverage may be sold at the show. Under certain conditions, the sale of packaged gourmet food items (for off premises consumption) may be approved through Show Management. It is the responsibility of the Vendor to obtain written permission (30) days in advance of show date(s). All food permits, concessionaire fees, and/or necessary documentation is the responsibility of the Vendor, and under no circumstances will Vendor receive a refund for failure to comply, and/or obtain the necessary documentation.
11. **Payments & Cancellations:** All payments are non-refundable* Vendor is responsible for payment in full as per contract, regardless of cancellation.
12. **Door Prize:** Vendor is responsible for providing a \$15 (value) prize at the time of check-in on the day of the Event. This item will be used as a door prize by Event organizer.
13. **Permits:** Vendor is fully responsible for obtaining any licenses or permits if required by the City of Aransas, County or State for the product Vendor is selling at Showcase.
